**ORDER GRANTING IN PART
PETITION TO ENFORCE CIVIL
INVESTIGATIVE DEMAND (Doc. 1)**

1 Before the Court is the Consumer Financial Protection Bureau’s (CFPB) Petition to
2 Enforce Civil Investigative Demand. (Pet., Doc. 1.) Respondent Seila Law, LLC, has
3 submitted an Opposition (Opp’n, Doc. 20), and the CFPB has filed a Reply (Reply, Doc.
4 21). After carefully reviewing the papers, the Court GRANTS IN PART the Petition.

5 **I. BACKGROUND**

6 On February 27, 2017, the CFPB issued a Civil Investigative Demand to Seila Law,
7 LLC, which included a notification of purpose, indicating:

8 The purpose of this investigation is to determine whether debt relief
9 providers, lead generators, or other unnamed persons are engaging in
10 unlawful acts or practices in the advertising, marketing, or sale of debt relief
11 services or products, including but not limited to debt negotiation, debt
12 elimination, debt settlement, and credit counseling, in violation of Sections
13 1031 and 1036 of the Consumer Financial Protection Act of 2010, 12 USC
14 §§ 5531, 5536; 12 U.S.C. § 5481 et seq., the Telemarketing Sales Rule, 16
15 C.F.R. § 310.1 et seq., or any other Federal consumer financial law. The
16 purpose of this investigation is also to determine whether Bureau action to
17 obtain legal or equitable relief would be in the public interest.

18 (CID, Exh. 1, Doc. 1-2.) On March 19, 2017, Seila Law filed a petition to set aside or
19 modify the Civil Investigative Demand (Pet. Set Aside, Exh. 5, Doc. 20-1), which the
20 CFPB Director denied on April 10, 2017 (CFPB Decision, Exh. 2, Doc. 1-2). The decision
21 ordered Seila Law to “produce all responsive documents, items, and information within its
22 possession, custody, or control that are covered by the CID” within ten days. (*Id.* at 5.)
23 Seila Law asked for extension of time to comply with the CID, which the CFPB granted.
24 (Singelmann Decl. ¶ 9, Doc. 1-2.)

25 On April 27, 2017, Seila Law submitted its response to the CID. (*Id.* ¶ 10.) A week
26 later, the CFPB sent Seila Law a letter claiming that Seila Law’s response improperly
27 asserted general objections, failed to provide a privilege log for claims of attorney-client
28 and attorney work product privilege, raised untimely claims of privilege, withheld relevant

1 documents based on assertions of “confidentiality,” and otherwise provided incomplete or
 2 deficient responses. (CFPB May 4 Letter, Exh. 3, Doc. 1-2.) Seila Law responded in a
 3 letter dated May 22, 2017, challenging the “the enforceability of the CID” and “declin[ing]
 4 the CFPB’s request at this time to provide further information or documents in response to
 5 the CID.” (Seila Law Letter May 22, Exh. 4, Doc. 1-2.) In response, the CFPB filed this
 6 Petition to Enforce its Civil Investigative Demand. (Pet., Doc. 1.)

7 **II. LEGAL STANDARD**

8 “To determine whether to enforce an administrative subpoena, a court considers ‘[1]
 9 whether Congress has granted the authority to investigate; [2] whether procedural
 10 requirements have been followed; and [3] whether the evidence is relevant and material to
 11 the investigation.’” *CFPB v. Future Income Payments, LLC*, No. 8:17-CV-00303-JLS-SS,
 12 2017 WL 2190069, at *2 (C.D. Cal. May 17, 2017) (quoting *EEOC v. Children’s Hosp.*
 13 *Med. Ctr. of N. Cal.*, 719 F.2d 1426, 1428 (9th Cir. 1983) (en banc), *overruled on other*
 14 *grounds as recognized in Prudential Ins. Co. v. Lai*, 42 F.3d 1299, 1303 (9th Cir. 1994)).
 15 If the agency has satisfied these “narrow” requirements, a court should enforce an
 16 administrative subpoena unless the respondent can demonstrate that compliance would
 17 pose an undue burden. *Id.*; *Children’s Hosp. Med. Ctr. of N. California*, 719 F.2d at 1428.
 18 In response to a petition to enforce an administrative subpoena, a subpoenaed party is free
 19 to raise any constitutional challenges, which this Court reviews on a plenary basis. *Future*
 20 *Income Payments*, 2017 WL 2190069, at *2.

21 **III. DISCUSSION**

22 Seila Law objects to the enforcement of the CFPB’s Civil Investigative Demand
 23 because, it asserts, (1) the CFPB is unconstitutionally structured, (2) the notification of
 24 purpose is inadequate, (3) the CFPB’s practice of law exclusion would preclude any
 25 enforcement action, and (4) the CID is overly broad and seeks privileged information.¹
 26 (Opp’n 10–16.) The Court considers each argument in turn.

 28 ¹ The Court does not separately consider Seila Law’s fleeting Fourth and Fifth Amendment
 objections because they are entirely derivative of its other arguments. (*See* Opp’n at 8.)

1 **A. CFPB’s Constitutionality**

2 In *CFPB v. Morgan Drexen* and *CFPB v. Future Income Payments*, this Court
3 addressed the same constitutional challenges that Seila Law raises. *See Future Income*
4 *Payments*, 2017 WL 2190069, at *6–9; *CFPB v. Morgan Drexen, Inc.*, 60 F. Supp. 3d
5 1082, 1086–92 (C.D. Cal. 2014). Like the respondent in *Future Income Payments*, Seila
6 Law relies heavily on the arguments advanced in *PHH Corp. v. CFPB*, a vacated 2-1
7 decision from the D.C. Circuit that this Court continues to find unpersuasive. (*See Opp’n*
8 at 3–7.) Notably, the *PHH* majority acknowledged, “‘there is no meaningful difference in
9 responsiveness and accountability to the President’ between an agency headed by a
10 commission and a director.” *Future Income Payments*, 2017 WL 2190069, at *7 (quoting
11 *PHH*, 839 F.3d at 32). “That is enough to end the inquiry” because the controlling
12 standard enunciated in *Morrison v. Olson* is whether the CFPB Director’s for-cause
13 protection from removal “‘interfere[s] with the President’s exercise of the ‘executive
14 power’ and his constitutionally appointed duty to ‘take care that the laws be faithfully
15 executed’ under Article II.” *Id.* (quoting *Morrison v. Olson*, 487 U.S. 654, 690 (1988)).
16 Even if *Morrison* were not controlling, there is no meaningful constitutional distinction
17 that could be drawn between the CFPB and other director-led independent agencies, such
18 as the Social Security Administration, and “no empirical evidence . . . establishes the
19 superiority of either” director or multimember-led independent agencies. *Id.* at *5–8.

20 To the extent that Seila Law argues that the CFPB is unconstitutionally structured
21 because the agency receives funding outside of the annual Congressional appropriations
22 process (*Opp’n* at 7), the CFPB is no different than several other financial regulators, such
23 as the Federal Reserve Board, the Office of the Comptroller of the Currency, and the
24 Federal Deposit Insurance Corporation. *See* Adam J. Levitin, *The Consumer Financial*
25 *Protection Bureau: An Introduction*, 32 Rev. Banking & Fin. L. 321, 343 (2013). In fact,
26 unlike these other agencies, the CFPB’s non-appropriated budget is capped by statute. *See*
27 *id.* Further, “[t]he Appropriations Clause ‘does not in any way circumscribe Congress
28 from creating self-financing programs . . . without first appropriating the funds as it does in

1 typical appropriation and supplement appropriation acts.” *Morgan Drexen*, 60 F. Supp.
2 3d at 1089 (quoting *AINS, Inc. v. United States*, 56 Fed.Cl. 522, 539 (Fed. Cl. 2003), *aff’d*,
3 365 F.3d 1333 (Fed. Cir. 2004), *abrogated on other grounds by Slattery v. United States*,
4 635 F.3d 1298 (Fed. Cir. 2011)). *Accord Am. Fed’n of Gov’t Employees, AFL–CIO, Local*
5 *1647 v. Fed. Labor Relations Auth.*, 388 F.3d 405, 409 (3d Cir. 2004) (“Congress itself
6 may choose . . . to loosen its own reins on public expenditure. . . . Congress may also
7 decide not to finance a federal entity with appropriations.”).

8 Even assuming that *Morrison* were not controlling *and* an independent agency
9 could not be constitutionally headed by a director, the proper remedy would not be to
10 refuse to enforce the CID. *Future Income Payments*, 2017 WL 2190069, at *9. In *Buckley*
11 *v. Valeo*, for example, the Supreme Court held that the process for appointing
12 commissioners to the Federal Election Commission trammelled upon the President’s
13 Appointments Power. 424 U.S. 1, 140 (1976). Yet, the Court held, “[i]nsofar as the
14 powers confided in the Commission are essentially of an investigative and informative
15 nature” the agency may execute them because Congress may properly establish offices that
16 “perform duties . . . in aid of those functions that Congress may carry out by itself.” *Id.* at
17 138–39. Because Congress unquestionably wields the subpoena power, *see, e.g., Eastland*
18 *v. U. S. Servicemen’s Fund*, 421 U.S. 491, 504 (1975), the CFPB may lawfully execute this
19 authority as well. *Future Income Payments*, 2017 WL 2190069, at *9; *see In re*
20 *Application of President’s Comm’n on Organized Crime*, 763 F.2d 1191, 1201–02 (11th
21 Cir. 1985) (Fay, J., writing separately).

22 **B. Notification of Purpose**

23 Seila Law further protests that the CID fails to provide sufficient notice about the
24 purpose and contours of the CFPB’s investigation. (Opp’n at 9–10.) As recounted
25 already, the CID’s notification of purpose provides:

26 The purpose of this investigation is to determine whether debt relief
27 providers, lead generators, or other unnamed persons are engaging in
28 unlawful acts or practices in the advertising, marketing or sale of debt relief

1 services or products, including but not limited to debt negotiation, debt
2 elimination, debt settlement, and credit counseling, in violation of Sections
3 1031 and 1036 of the Consumer Financial Protection Act of 2010, 12 USC
4 §§ 5531, 5536; 12 U.S.C. § 5481 et seq., the Telemarketing Sales Rule, 16
5 C.F.R. § 310.1 et seq., or any other Federal consumer financial law. The
6 purpose of this investigation is also to determine whether Bureau action to
7 obtain legal or equitable relief would be in the public interest.

8 (CID, Exh. 1.)

9 “The authority of an administrative agency to issue subpoenas for investigatory
10 purposes is created solely by statute.” *United States ex rel. Richards v. De Leon Guerrero*,
11 4 F.3d 749, 753 (9th Cir. 1993) (quoting *Peters v. United States*, 853 F.2d 692, 696 (9th
12 Cir.1988)). Section 5562, which empowers the CFPB to issue civil investigative demands,
13 provides that “[e]ach civil investigative demand shall state the nature of the conduct
14 constituting the alleged violation which is under investigation and the provision of law
15 applicable to such violation.” 12 U.S.C. § 5562(c)(2). The CFPB’s implementing
16 regulation likewise provides that a subpoenaed person “shall be advised of the nature of
17 the conduct constituting the alleged violation that is under investigation and the provisions
18 of law applicable to such violation.” 12 C.F.R. § 1080.5. Yet, like every other
19 administrative agency, the CFPB can define the contours of its investigation “quite
20 generally” while still complying with its statutory obligations. *FTC v. Invention*
21 *Submission Corp.*, 965 F.2d 1086, 1088, 1090 (D.C. Cir. 1992); *see FTC v. Carter*, 636
22 F.2d 781, 784, 787–89 (D.C. Cir. 1980) (approving of a very broad notification of
23 purpose); *FTC v. Texaco, Inc.*, 555 F.2d 862, 868, 874 & n. 26 (D.C. Cir. 1977) (same).

24 A few examples illustrate when an agency crosses from defining the scope of its
25 investigation broadly, which it may do, to violating its statutory notice requirements. In
26 *Peters v. United States*, the Ninth Circuit held that, although the Immigration and
27 Naturalization Service had a “broad subpoena and investigatory authority,” it could not
28 issue so-called “John Doe” subpoenas, which demand information about unknown targets

1 of an investigation from third parties. 853 F.2d 692, 696–99 (9th Cir. 1988). Similarly, in
2 *In re Sealed Case (Admin. Subpoena)*, the D.C. Circuit affirmed the district court’s
3 determination that the Office of Thrift Supervision could seek information for two stated
4 purposes, but determined that the agency had no authority to demand information for a
5 third proffered purpose, namely to determine whether the targets of the investigation
6 committed “other wrongdoing, as yet unknown.” 42 F.3d 1412, 1415–19 (D.C. Cir. 1994).
7 More recently, in *CFPB v. Accrediting Council for Independent Colleges & Schools*, the
8 D.C. Circuit held that a notification of purpose stating that “the purpose of this
9 investigation is to determine whether any entity or person has engaged or is engaging in
10 unlawful acts and practices in connection with accrediting for-profit colleges” failed to
11 identify adequately the conduct subject to the investigation. 854 F.3d 683, 690 (D.C. Cir.
12 2017). The D.C. Circuit reaffirmed that “a notification of purpose may use broad terms to
13 articulate an investigation’s purpose[,]” but found that “§ 5562(c)(2) mandates that the
14 Bureau provide the recipient of the CID with sufficient notice as to the nature of the
15 conduct and the alleged violation under investigation.” *Id.* The notification of purpose
16 provided no clue about what “unlawful acts and practices” were under investigation. *Id.*
17 This shortcoming made it impossible to determine what the CFPB was investigating or
18 whether any investigation was within the scope of its statutory authority. *Id.* at 690–91.

19 Seila Law cleverly uses ellipses to suggest that the CID’s notification of purpose
20 provides no clue about the nature of the CFPB’s investigation other than that the agency
21 seeks “to determine whether . . . unnamed persons are engaging in unlawful acts or
22 practices in the advertising, marketing, or sale of debt relief services or products . . . in
23 violation of . . . any other Federal consumer financial law.” (Opp’n at 9–10.) But what
24 Seila Law omits through ellipses provides the fair notice that it supposedly seeks. The
25 CID identifies specific types of businesses under investigation (“debt relief providers” and
26 “lead generators”), the conduct subject to investigation (“advertising, marketing, or sale of
27 debt relief services or products, including but not limited to debt negotiation, debt
28 elimination, debt settlement, and credit counseling”), and specific statutes and regulations

1 that may have been violated (such as the Telemarketing Sales Rule, 16 C.F.R. § 310.1 *et*
2 *seq.*). Seila Law’s argument reduces to arguing that an administrative agency cannot use
3 more general categories at the end of lists in a notification of purpose. That, however, is
4 not the law. The D.C. Circuit has long affirmed the use of such phrasing, *see, e.g., Texaco,*
5 *Inc.*, 555 F.2d at 868 (approving of a notification of purpose that listed certain companies
6 and then included the more general phrase “other persons and corporations”), and
7 *Accrediting Council for Independent Colleges & School* held simply that a notification of
8 purpose cannot include *only* broad catch-alls. Indeed, under the *eiusdem generis* and
9 *noscitur a sociis* canons of construction, the broader categories included in this CID are
10 limited based on the other items included in the lists. And, unlike in *Peters*, the CFPB is
11 not seeking to enforce a John Doe subpoena; the CFPB seeks information *about* Seila Law
12 *from* Seila Law. Accordingly, Seila Law’s contention that the CID’s notification of
13 purpose is inadequate lacks merit.

14 **C. Practice of Law Exclusion**

15 Seila Law next contends the CFPB’s practice of law exclusion would bar any
16 enforcement action against it. (Opp’n at 10–14.) This Court recently rejected this
17 argument in the related case *CFPB v. Howard*. *See* Order Denying Defendants’ Motion to
18 Dismiss at 5–8, Doc. 42, Case No. 8:17-cv-00161-JLS-JEM (May 26, 2017). To
19 summarize, section 5517(e)(3) (“Paragraph 3”) provides that the Consumer Financial
20 Protection Act’s general prohibition against the CFPB regulating the practice of law “shall
21 not be construed so as to limit the authority of the Bureau with respect to any attorney, to
22 the extent that such attorney is otherwise subject to any of the enumerated consumer laws
23 or the authorities transferred under subtitle F or H.” 12 U.S.C. § 5517(e)(3). Section
24 1100C in subtitle H of the Consumer Financial Protection Act empowers the CFPB to
25 enforce the Telemarketing Sales Rule, a regulation promulgated by the FTC that does not
26 contain an exception for those engaged in the practice of law. *See* Dodd-Frank Wall Street
27 Reform and Consumer Protection Act, Pub. L. No. 111–203, § 1100C, 124 Stat. 1376,
28 2111 (2010); *see also* Telemarketing Sales Rule, 75 Fed. Reg. 48458, 48467–69 (Aug. 10,

1 2010) (declining to make an exception for the practice of law in the TSR amendments).
2 As such, the practice of law exclusion does not bar the CFPB from enforcing the
3 Telemarketing Sales Rule against Seila Law. *See FTC v. Lanier Law, LLC*, 194 F. Supp.
4 3d 1238, 1283 (M.D. Fla. 2016). While Seila Law references a district court that adopted a
5 contrary interpretation based on policy concerns (Opp’n at 12–13), this Court opts instead
6 to follow the plain meaning of Paragraph 3, which unmistakably empowers the CFPB to
7 take enforcement actions against attorneys under the transferred authorities insofar as those
8 transferred authorities implicate the practice of law. Congress included the practice of law
9 exclusion to ensure that the CFPB did not employ its general authority over unfair,
10 deceptive, and abusive practices to regulate the practice of law. Order Denying
11 Defendants’ Motion to Dismiss at 7, Doc. 42, Case No. 8:17-cv-00161-JLS-JEM (May 26,
12 2017). But, to the extent that Congress enacted other statutes that already affect the legal
13 field, nothing in the practice of law exclusion suggests Congress intended a massive
14 curtailment of federal enforcement authority. *Id.*

15 Seila Law’s contrary interpretation—that Paragraphs 3 merely means that “an
16 attorney is not exempt from enforcement by the CFPB merely because of his or her status
17 as an attorney” (Opp’n at 13)—would render it entirely superfluous because section
18 5517(e)(2) (“Paragraph 2”) already accomplishes this. *See* 12 U.S.C. § 5517(e)(2)
19 (allowing the CFPB to regulate attorneys’ provision of covered products that are “not
20 offered or provided as part of, or incidental to, the practice of law” or that are provided to a
21 consumer “who is not receiving legal advice or services from the attorney in connection
22 with such financial product or service”). “A cardinal principle of statutory construction”
23 teaches that “a statute ought, upon the whole, to be so construed that, if it can be
24 prevented, no clause, sentence, or word shall be superfluous, void, or insignificant.” *TRW*
25 *Inc. v. Andrews*, 534 U.S. 19, 31 (2001) (quoting *Duncan v. Walker*, 533 U.S. 167, 174
26 (2001)). Paragraph 3 offers a classic instance where the canon against surplusage should
27 be applied: Seila Law’s construction would mean, quite improbably, that Congress
28 fashioned an entirely redundant statutory provision immediately following the provision

1 that would render that provision redundant. Because courts should resist ascribing such
2 odd statutory drafting to Congress and the plain language supports the CFPB’s
3 construction, the Court concludes that the practice of law exclusion would not bar an
4 enforcement action by the agency.

5 **D. Overbreadth and Vagueness**

6 Seila Law finally challenges a few of the CID’s interrogatories and requests for
7 documents as overbroad or vague. (Opp’n at 14–16.) The CFPB responds that Seila Law
8 has waived these arguments, and that the CID seeks only relevant information. (Reply at
9 13–16.)

10 “Courts ‘generally will not entertain a challenge to a subpoena that was not first
11 brought before the [administrative agency].’” *NLRB v. Uber Techs., Inc.*, 216 F. Supp. 3d
12 1004, 1007 (N.D. Cal. 2016) (quoting *NLRB v. Fresh & Easy Neighborhood Mkt., Inc.*,
13 805 F.3d 1155, 1159 (9th Cir. 2015)). This administrative exhaustion requirement “is
14 grounded in important prudential considerations, such as providing an agency with the
15 opportunity to correct its mistakes before it is haled into court and ensuring that parties do
16 not employ judicial review to weaken an agency’s administrative processes.” *Seraji v.*
17 *Gowadia*, No. 8:16-CV-01637-JLS-JCG, 2017 WL 2628545, at *3 (C.D. Cal. Apr. 28,
18 2017) (Staton, J.); *see Fresh & Easy Neighborhood Mkt., Inc.*, 805 F.3d at 1159 (noting
19 that the exhaustion requirement reflects “deference to the Board’s interest and expertise in
20 managing the cases before it”). Courts have excused a subpoenaed party’s failure to
21 exhaust its administrative remedies where it raises a constitutional challenge or identifies
22 “exceptional circumstances.” *Uber Techs., Inc.*, 216 F. Supp. 3d at 1007; *see EEOC v.*
23 *Lutheran Soc. Servs.*, 186 F.3d 959, 964–67 (D.C. Cir. 1999); *EEOC v. Cuzzens of*
24 *Georgia, Inc.*, 608 F.2d 1062, 1064 (5th Cir. 1979).

25 Seila Law raised its overbreadth and vagueness objections to certain interrogatories
26 and requests for documents in its petition to set aside or modify the CID. (Pet. Set Aside,
27 Exh. 5.) The CFPB declined to consider these arguments, reasoning that Seila Law failed
28 to comply with 12 C.F.R. § 1080.6 because it did not “submit specific modification

1 requests in writing” during the meet-and-confer process. (CFPB Decision at 4–5, Exh. 2.)
2 The applicable regulation, however, does not provide that a party waives its challenges by
3 failing to submit proposed written modifications during the meet-and-confer process; all it
4 says is that, in a petition to set aside a CID, the agency “will consider only issues raised
5 during the meet-and-confer process.” 12 C.F.R. § 1080.6(c)(3). Because neither side
6 suggests that Seila Law failed to raise its specific concerns during the meet-and-confer
7 process, Seila Law did not waive these objections.

8 Seila Law contends that the CID’s request for information about “other services,” or
9 simply “services,” could be construed to encompass information related to the firm’s
10 immigration, personal injury, criminal defense, and real estate practices that have nothing
11 to do with the stated purposes of the subpoena. (Opp’n at 15–16; *see also* Opp’n at 11–
12 12.) The Court agrees. The CID does not define what “other services” are, and the CFPB
13 has not articulated how any investigation into Seila Law’s immigration, personal injury,
14 criminal defense, or real estate practices would not be barred by the CFPB’s practice of
15 law exclusion. The Court will accordingly limit the definition of “other services” in
16 Interrogatories Nos. 5 and 6 to the areas of inquiry identified in the CID that would not be
17 barred by the CFPB’s practice of law exclusion, specifically the “advertising, marketing,
18 or sale of debt relief services or products,” including “debt negotiation, debt elimination,
19 debt settlement, and credit counseling.” (CID, Exh. 1.) Similarly, the mention of
20 “services” in Interrogatory No. 5 and Requests for Documents Nos. 2 and 4 shall be
21 limited to the “advertising, marketing, or sale of debt relief services or products,” including
22 “debt negotiation, debt elimination, debt settlement, and credit counseling.” By narrowing
23 the definition of “other services” and “services,” the Court also ensures that the definition
24 of “consumer” will not sweep in information unrelated to the stated lawful purpose of this
25 investigation.² (*See* Opp’n at 15.)

26
27 ² Seilia Law contends that the CFPB cannot seek information about attorneys’ marketing
28 of “debt relief and other services,” because states have traditionally regulated attorney advertising.
(Opp’n at 15.) But the Telemarketing Sales Rule bars certain marketing practices for debt relief

1 Separately, Seila Law complains that the term “affiliated” in Interrogatory No. 4—
2 and by cross-reference Request for Documents No. 3—is vague or overbroad. (Opp’n at
3 14–15.) As the CFPB has not defined the term, there is no reason to suggest that the word
4 should not take its commonsense meaning in this context—specifically, those who had a
5 close professional connection or association with Seila Law or Aissac Seila Aiono during
6 the relevant period. *See, e.g.*, Merriam-Webster’s Collegiate Dictionary 21 (11th ed.
7 2003). Under this plain-meaning interpretation, the Court rejects Seila Law’s suggestion
8 that the word “affiliated” is vague or overbroad. The requested information is necessary,
9 for instance, to determine whether “the Howard defendants . . . transferred the debt relief
10 business, including the files of former Morgan Drexen consumers, to Seila Law.” (Notice
11 of Related Case at 3, Doc. 5.)

12 Finally, Seila Law claims that the CID seeks information protected by the attorney-
13 client and work product privileges. (Opp’n at 16.) But, like in any civil litigation, Seila
14 Law must first make an adequate privilege log (*see* CID at Instruction D, Exh. 1), which it
15 has not done yet. Thus, with the narrowing construction, the Court finds that the CID
16 seeks only relevant information and is not vague.

17 **IV. CONCLUSION**


18 For the aforementioned reasons, CFPB’s Petition is GRANTED IN PART. Seila
19 Law is hereby COMPELLED to comply with the CID within ten (10) days of this Order or
20 at a later date as may be established by this Court or the CFPB, except for the following
21 limitations to the definition of “other services” and “services” in the CID. “Services” and
22 “other services” shall be construed to mean the “advertising, marketing, or sale of debt
